The Fulton County Courthouse will be **CLOSED** for normal business on December 26 and December 27, 2024.



All such offices named above **SHALL REOPEN TO THE PUBLIC** at normal business hours on Monday, December 30, 2024. **PLEASE NOTE**: All Fulton County Magistrate Court EWI and First Appearance Calendars to be conducted virtually via Zoom will proceed as scheduled

Ex parte requests for Protective Orders shall be heard by the presiding Judicial Officer on those dates. All other Family Division matters will resume on Monday December 30, 2024.
