

How to Join Jury Selection via Zoom

If you have received a post card for virtual jury selection via Zoom, please follow the instructions below to download and install Zoom, and to join the jury selection on the date and time.

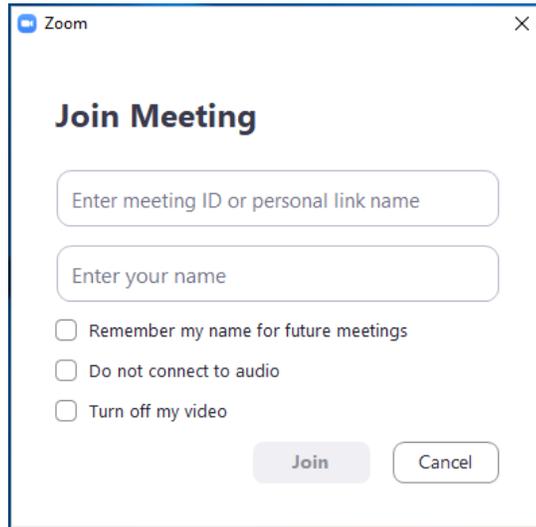
3. Click on the Zoom link contained in the email you received after filling the Jury Questionnaire. Accepted into the waiting room of the Virtual Jury Selection and the Jury Clerk will admit you into the meeting.



4. You may also join the selection by double clicking on the Zoom app, and clicking “Join a Meeting” in the window that pops up.

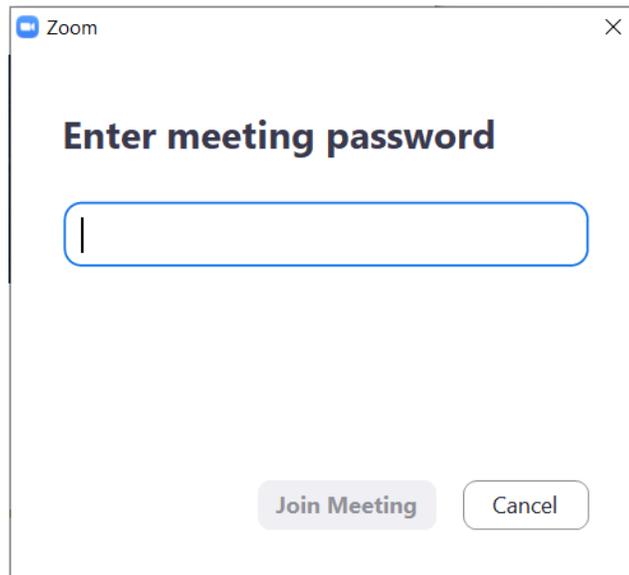


5. In the “**Join a Meeting**” window that pops up next, enter the Meeting ID and your full name and click the Join button
