#### **Virtual Jury Selection: What to Expect**

**VERY IMPORTANT**: Jurors will appear for jury duty remotely via the Zoom video conference below on the date and time listed. <u>Jury selection will be performed remotely via Zoom</u>, <u>not in person</u>. \*Please note, if chosen to serve as a juror via Zoom, you will report to the courthouse for the trial.

What to expect on your report date for Virtual/Remote Jury Selection:

# 1. <u>Jury Selection will be conducted by video conference using the ZOOM Meeting Application.</u>

You should have reviewed a set of questions in order to ensure you have access to the following:

- A computer, tablet or cellphone that has a webcam or camera.
- High speed or broadband internet access or an internet data plan with unlimited data.
- A private place where you can use the internet without interruption from others.
- Depending on the device you are using, you may need to download the ZOOM application and should do so prior to your actual report date. Please <u>click here</u> for instructions to help you do this and for using Zoom.

\*\*If you do not have the required equipment, Fulton County will provide you with the equipment at the courthouse well in advance of your service date. Please contact Jury Services at (404) 612-4600 or email us at info,juryservices@fultoncountyga.gov.

Please note, if chosen to serve as a juror for a particular case, you will report to the courthouse for the trial, as directed by the trial judge.

## 2. <u>How do I know where to join the ZOOM Meeting on my report date for jury duty</u> service?

You can join the ZOOM Meeting with the URL link or Meeting ID on your postcard or on the email you received from us.

3. Where is my email from the Court with Zoom information? After you completed the juror questionnaire and clicked "yes" to the technology questions, an email was automatically sent to the email address you provided on your questionnaire. If you do not see the email in your inbox, please check your spam and junk folders.

If you still cannot locate the email, please contact us at <a href="mailto:info.juryservices@fultoncountyga.gov">info.juryservices@fultoncountyga.gov</a> or by phone at (404) 612-4600 well in advance of your service date. We will not be manning the phones during your report time because we are checking in jurors. Our phones are manned from 10:00AM to 4:30PM Monday through Friday.

## 3. What do I do if I am having technical difficulties or unable to get into the meeting?

If you experience any technical difficulties on the date of your jury duty service, you must contact Jury Services by email at <a href="mailto:info.juryservices@fultoncountyga.gov">info.juryservices@fultoncountyga.gov</a> or via phone at (404) 612-4600.

#### 4. What will happen on the actual report date?

You will appear for jury duty service by joining the ZOOM video conference by clicking the link in the email you received OR by going to zoom.com and entering the meeting ID and password provided in the email we sent you. <u>DO NO SHARE THE ZOOM</u> MEETING LINK OR MEETING ID WITH ANYONE.

- Jury Services will check you in for jury duty and additional instructions will be given to you at that time.
- You must have your camera on throughout the duration of jury duty.
- Do not schedule additional activities starting on the anticipated report date listed above.
- Audio and video recording is prohibited.
- You must remain on the ZOOM Meeting until you are released by the Judge.
